

Stop the Lockdown & No to Enforced Vaccinations

Petition to the UK Prime Minister Boris Johnson

The steps taken by the British government in relation to Covid-19 are very concerning. Lockdown measures are destroying the economy; thousands of people have lost their jobs; businesses are struggling. Introducing mandatory vaccinations is a violation of human rights.

We demand the government changes course immediately:

- **End the lockdown**
- **Open the economy**
- **Guarantee citizens the freedom of health care**

Why this needs to happen:

- **Claimed death rates are false**

Death rate figures are skewed and incorrectly recorded. In March 2020, the WHO changed its death recording guidelines. If Covid-19 is mentioned on a patient's death record, doctors are now obliged to record Covid-19 as their cause of death. Any pre-existing medical conditions are disregarded, even if these conditions were the actual cause of death.

- **Covid-19 is no more dangerous than other infectious diseases**

This virus is no more infectious than other similar viruses such as the Swine Flu.

■ **Covid-19 has not killed more people compared to previous years**

According to the UK Office of National Statistics, the number of deaths which have occurred in the first three months of 2020 are comparable to the death rates of the previous three years (for the same timeframe) when there was no Covid-19.

■ **Other countries are not locked down and are doing fine**

Sweden and Japan did not implement drastic lockdown measures. Jobs and businesses have not been destroyed. Infection rates didn't increase.

■ **Biased self-announced experts predicted the future**

Bill Gates' foundation had foreknowledge that a pandemic would be declared; this foundation has business interests in global vaccination programmes. Experts advising the government are connected to this foundation.

■ **Lockdown has created more deaths and societal issues**

Cancelled needed operations and treatments means people are not getting the treatment they need. Heightened stress and anxiety have increased mental illnesses and suicide. Domestic violence is at an all-time high.

■ **Devastating effect on personal lives and the economy**

Businesses have collapsed and people have lost their jobs; many are now unable to pay their rent or mortgage, and some are in dire straits.

■ **Vaccinations are unsafe, being pushed by company interests**

They contain unsafe, toxic ingredients. The Swine Flu vaccine caused 25 deaths and incurred claims of \$1.3 billion from victims who suffered paralysis from the vaccine.

■ **Mandatory vaccinations violate human rights**

Forcing people to vaccinate is a fundamental breach of human rights and a violation of article 6 of the UNESCO 2005 Statement on Bioethics and Human Rights.
